Sub: Grant of Provisional Affiliation for the Year 2007-08.

I have been directed to convey that on the recommendations of sub-affiliation committees of State Board of Technical Education, Haryana and approval of AICTE it has been decided to grant provisional affiliation for the year2007-08 to the Polytechnic for the intake as approved by State Level Committee and AICTE.

Initially the affiliation shall be on annual basis and there after based on the yearly performance of the Polytechnic it may be considered for permanent affiliation.

Provisional affiliation has been accorded subject to the fulfillment of minimum norms and standards of the SBTE for the sanctioned courses and intake as approved by the competent authority. The Polytechnic/ Institute has to deposit affiliation fee i.e. Institutional affiliation fees is Rs. 25000/- and Per course affiliation fees @ Rs. 15000/- per course along with the affiliation Performa with in 15 days after the receipt of AICTE approval letter.

The Polytechnic/Institute has to made admissions through Haryana State Counseling Society only and no excess admissions shall be made. The Polytechnic/Institution shall strictly adhere to the policy framework of SBTE/AICTE from time to time. The Polytechnic shall adhere to all the norms as specified for faculty and pay scales, infrastructure facilities, laboratory, workshops, machinery, equipments, computer facilities, Library facilities and other facilities as desirable. BOG of the Polytechnic shall ensure that admissions are made in a fare transparent manner and the utilization of the institutional resources including student fund is for welfare of students.

In the event of infringement/ contravention of non-compliance of the SBTE affiliation norms and / or the provisions as specified by the State Government/ norms and standards as prescribed by AICTE/PCI, further action leading to Reduced Intake, No Admissions or Withdrawal of Affiliation may be taken by SBTE and the liability arising out of such actions shall be solely of the management of the Polytechnic/ Institution.
